Weight Room Participation Registration

WEIGHT ROOM HOURS: The school is open for registered weight room participants from 6:00am -7:30am and 3:30pm – 9:30pm when school is in session, September through May. Hours may be changed without notice to accommodate sporting events and after school activities.

APPROVAL OF USE and RULES: Weight room participants must watch a safety video which is 24 minutes in length. The video is available at the Community Education office. Once you have watched the video and turned in the Liability Waiver you will be added to a list of approved weight room participants. We ask that you follow the weight room rules posted in the weight room. Please note for safety reasons, adult participants must work out with one other person - minimum of two people.

SIGNING IN/OUT and ACCESS: Weight room participants must sign in and out on the WEIGHT ROOM SIGN IN/OUT sheet located outside the weight room. Should the weight room be locked, please find a building custodian to unlock the door for you. Although this may be slightly inconvenient, we prefer to keep doors locked when not in use.

Participant Liability Waiver and Hold Harmless Agreement

Please read this waiver carefully and be aware that by registering for and participating in this program, you will be waiving your rights to all claims for injuries you might sustain arising out of this program and you will be required to indemnify, hold harmless, and defend the Glenwood City School District for any claims arising out of participation in said program.

RISK OF INJURY: “As a participant in the program, I recognize and acknowledge that there are certain risks of physical injury, and I agree to assume the full risk of injuries, including death, damages, or loss which I may sustain as a result of participating in any and all activities associated with this program.”

WAIVER OF INJURY CLAIMS: “I agree to waive and relinquish any and all claims I may have arising out of, connected with, or in any way associated with the activities of the program.”

RELEASE FROM LIABILITY: “I do hereby fully release and discharge the Glenwood City School District and its officers, agents, and employees from any and all claims from, injuries, including death, damage or loss which may have or which may occur on account of participation in the program.”

INDEMNITY AND DEFENSE: “I further agree to indemnify, hold harmless and defend the Glenwood City School District and its officers, agents, and employees from any and all claims from injuries, including death, damages and losses sustained by me or arising out of, connected with, or in any way associated with the activities of the program.”

In the event of any emergency, I authorize the Glenwood City School District to secure from any licensed hospital, physician, and /or medical personnel and treatment deemed reasonable and necessary and agree that I will be responsible for payment of any and all medical services rendered.

I have watched the WEIGHT ROOM SAFETY VIDEO and I have read and fully understand and agree to the weight room rules and the Participant’s Liability Waiver and Hold Harmless Agreement.
