- Pursuant to 2015 Wisconsin Act 55 section 118.57 of the state statute, the Glenwood City Area offers the following educational options. - As a result of the April 15, 2020, enactment of the 2019 Wisconsin Act 185, the coronavirus relief package, and the ESEA waiver granted by the Department of Education on March 27, all state and federal academic assessment requirements were suspended or waived for 2019-20 and there will be no new ESSA identifications or state accountability report cards issued during the 2020-21 school year. Requirements for the 2020-21 administration of statewide assessments remain unchanged under state and federal law. DPI has been granted a waiver from federal ESSA accountability provisions resulting from 2020-21 school year data by the Department of Education.
